Electives: The procedure to be adopted

After MBBS final (part 1) examination two months are to be designated for elective rotations in two blocks of 04 weeks each, which is compulsory for all the students.

Electives are to provide the learner with opportunities of diverse learning experiences in research/community projects.

Regular clinical postings shall continue during Block 1. Block 2 shall be done in clinical department or as a supervised learning experience at a rural or urban community clinic

For allocation of electives, the list of elective choices with detailed information on nature of electives, names of supervisors and number of learners in each elective is to be made available to students at least three months in advance.

A Counseling session with faculty mentors is to be organized to help the students for the selection and allotment of electives. Rules regarding attendance, work schedule, documentation & assessment for elective are to be disclosed to entire students.

75% attendance in the electives and submission of log book maintained during elective postings is required for eligibility to appear in final MBBS examination

Each preceptor is to be tagged with fixed number of students. Students are to be assessed in between and at end of elective with a Feedback, comments and /or grades.

Curriculum Committee of college headed by Dean will be responsible for design, conduct, implementation and evaluation of electives.

Each elective should have:

- Defined learning objectives
- Identified preceptor
- Timetable of activities
- List of learning resources
- Provision to be part of the team
- Prerequisites if any, to be completed before joining
- Defined formative assessments
- Requirements for portfolio & log book entry
- Program evaluation by stakeholders


